INSTRUCTIONS FOR USE

Spray the product uniformly on the parts to be treated of the air conditioner (body) and distribute with a cloth or paper. For the disinfectant activity, leave the product to act for at least 15 minutes in order to eliminate bacteria and fungi.

It does not require rinsing. It does not damage the materials. Before use, make sure that the equipment is disconnected. Wait for the treated parts to dry completely before starting the air conditioner.
